Minutes of a Meeting of the NH Association of Fire Chiefs

Thursday, November 14, 2024 - Virtual

Called to order at 0905 hours.

After a salute to the flag, a moment of silence was requested for departed members.

Welcome from Host: Chief Emanuel welcomed everyone.

INTRODUCTION OF MEMBERS. Chief Lemire read the names of members who had signed up and recorded those present.

President's Report: (Emanuel) –

- Chief Emanuel noted that he had represented the NHAFC and contributed to the Interim Report- EV & Lithium-Ion Battery Study Council (SB 430), which has been submitted to the Governor.
- Chief Emanuel noted that he had represented the NHAFC and contributed to the LEO/PFF/EMT Career Development Committee- Final Report, which has been issued from the Commissioner to the Governor.

- Emergency Communications Director Mark Doyle has request for a letter of support to the governor from the NHAFC. Recommendation to address under new business.
- The NHAFC issued a letter of thanks to Senator Sue Prentis for her efforts to address challenges that the NHAFC supports. Thank you Brent for support.
- He had a telephone conversation with PFFNH President Brian Ryll regarding actions being taken by PFFNH regarding the NH Retirement System.
- He has been corresponding with Manchester's Chief Cashin regarding questions about the NHAFC's position on the Londonderry Fire Department. Emanuel noted that the NHAFC has not been asked for comment regarding Londonderry and have not engaged in the dialogue as an Association. That he has not connected with Bo Butler or anyone from Londonderry and that neither the department or the chief, are not members of the NHAFC.
- He reported that he was pleased to represent the NHAFC at the IAFC NED conference and expo with a number of members to support Chief Jones being sworn in as the NED president.
- He reported that the 83rd NHMA Annual Conference was well attended and that he had received positive feedback from NHAFC members who presented the following programs:

Legislation:

We are currently monitoring the following bills:

HB 1333 Relative to Prohibiting State Agencies from Buying or Leasing Fleet Electric

Vehicles For 10 Years.

Status: Interim Study Report - Not recommended for future legislation

HB 1602 Relative to The Authority Of The Housing Appeals Board. Status: Interim Study Report - Not recommended for future legislation SB 365 Relative to the sale or use of lithium-ion batteries for electric bicycles, scooters or personal electric mobility devices.

Status: Interim Study Report - Not recommended for future legislation

The Legislative Service Requests (LSR's) for the upcoming legislative session are starting to be published. We will be monitoring and release a report of the bills we will be monitoring in a future monthly report.

Board of Fire Control:

The next Board of Fire Control meeting will be held on January 21, 2025 at 1:00 pm.

BUREAU OF INVESTIGATIONS:

In October, we received 19 incident notifications resulting in 8 scene responses. The Bureau of Investigations currently has 9 open arson or suspected arson investigations.

New cases (synopsis of some of our cases are listed below):

- On October 11, an investigator responded to a fire in Sandown. The cause is undetermined but not suspected to be incendiary.
- On October 24, investigators responded to Hudson to assist with the investigation of a motor vehicle fire determined to be incendiary. Hudson Police arrested and charged a person with arson.
- On October 25, investigators responded to Sharon to investigate multiple small fires in a house. They determined that the fires were incendiary and identified a suspect. Charges are pending completion of the investigation.
- On October 30, investigators responded to Greenville for a garage fire. The cause is undetermined but not suspected to be incendiary.

Fatal Fire/CO Incidents:

- On October 4, investigators responded to Bethlehem for a structure fire at a house, with one fatality. The cause is under investigation.
- On October 6, investigators responded to New London for a fatal motor vehicle crash which resulted in a fire. A passenger died in the crash and the driver was arrested by the New Hampshire State Police. The death was determined to be a result of the crash, not the resulting fire.
- On October 8, investigators responded to Northumberland after two people were found deceased in a house. Carbon monoxide poisoning

was initially suspected, but no evidence of a carbon monoxide release was found. The cause and manner of death are still pending results of toxicology tests.

• On October 13, investigators responded to Bedford for a carbon monoxide poisoning incident in a home in which two people died. The cause of the carbon monoxide release is under investigation.

There were three IGL canine deployments in October.

Youth Firesetter:

There were four new youth fire setter assessments/intakes in October.

Court:

On October 23, 2024, Nathan G. Nichols was found guilty in Merrimack Superior Court of one Class B Felony for Criminal Mischief and one Misdemeanor charge of Arson from fire investigations that occurred in 2022 and 2023.



- ➤ We have one vacancy for our part-time Program Coordinator for EMS Education Assessment Coordinator.
- ➤ We have one vacancy for our part-time Program Coordinator for Technical Rescue Programs.
- ➤ We have one vacancy for our part-time EMS Vehicle Inspector Coordinator.
- ➤ We have vacancies for EMS Vehicle Inspectors and are conducting interviews.

Grants

- ➤ The Raymond S. Burton Fire and EMS Training Facility infrastructure project continues to move forward.
 - Ongoing construction meetings are occurring on a regular basis.
 - The Phase II contract has been approval by the Governor and Executive Council with an expected start date early in 2025.
- We are in the process of applying for the 2024 AFG grant which is open from November 12th until December 20th.
- ➤ The NH EMT Training Program remains active with grant funding for training new and existing EMS providers. Contact our Division or NH Employment Security for details and question.
 - Funding will only be available through the end of 2024.

Special Projects

➤ We have been working with the Police Academy, Department of Safety personnel, federal partners and local public safety leaders on developing a coordinated strategic approach, training and management of active threat incidents.

- ➤ We are working with the NHAFC, PFFNH, State Fireman's Association, the Fire Marshal and Primex on performing a gap analysis in cancer awareness and training.
- ➤ With the passage of SB 352 we worked with the committee as outlined in the law to develop an early detection cancer screening pilot program plan. The committee developed the initial plan that was presented to the Commissioner of Safety and Governor, and the Governor approved the plan. We are working to finalize the RFP for this program.
- ➤ We continue to work with the NH Department of Insurance on the Ground Ambulance Cost Reporting Program and Study as part of the recently passed SB 407.
- ➤ We partnered with the Maine and Vermont Fire Training Academies on a federal grant to develop an EV training curriculum, fund EV training and a train the trainer program throughout all three states. The full application for the grant was submitted on April 30th for a three-year project, \$420,000 for each state specifically for delivery of EV training.
 - We were not awarded this grant. Three agencies were however awarded funding for development of training, and we will be following their progress.
- ➤ We continue to work on our website transition and improvements with NH DoIT. Much of this work is being done offline in preparation of a full transition to the new state web platform.
- ➤ The Law Enforcement Officers, Professional Firefighters and Emergency Medical Technicians Career Development, Recruitment and Retention Program established in New Hampshire RSA 188-F:70 remains active and available.
 - Details can be found on our website under the Recruitment and Retention link from the homepage.
 - The annual report was submitted by the committee to Governor and legislative leaders as required by law.

Legislative/Administrative Rules

- ➤ The Fire Standards and Training Commission amended Fire rules relative to the Recruitment and Retention report and its recommendations have been submitted to the Joint Legislative Committee on Administrative Rules (JLCAR).
- > The proposed Trauma Rules are working through the internal legal process.
- ➤ An EMS discipline related administrative rule proposal has been drafted and is working through the internal legal process. This proposed change is supported by the EMS Coordinating Board and would allow for deceased providers names to be removed the public listing.
- ➤ We are working through the internal legal process for provisional EMS License rules following the passage of HB 1057 in the last legislative session.

Outreach

> Staff members continue to attend various stakeholder and mutual aid group meetings and make department visits.

Mental Health & Resiliency

- ➤ We are working with our Mental Health Seminar planning group on the 2025 seminar which is planned for January 7-8, 2025 at the Richard Flynn campus in Concord. The content and presenters have been finalized and registration is expected to open in November.
- ➤ We continue our work in partnership with the Police Academy to develop a more comprehensive program for PTSD training utilizing experts from this field in development of the curriculum and delivery.
 - The Governor and Executive Council have approved a contract with Dr. Nicole Sawyer to serve as the mental health professional consultant on this project which is set to begin later this month.

Fire Standards and Training Commission

- ➤ The next Fire Standards and Training Commission meeting will be January 9th at 1000 in Classrooms 5/6 in the dormitory building at the Richard Flynn Fire Academy in Concord.
- ➤ The NH Fire Standards and Training Commission has approved the written comment period to open through November 12, 2024 to January 11, 2025 for public comment on the proposed administrative update to the Airport Firefighter curriculum.
 - Public comment can be submitted at: https://nhfa-ems.com/fst-commission-curriculum-public-feedback-form/. Public hearings are in the process of being schedule and will be announced shortly.

- ➤ The NH Fire Standards and Training Commission (FSTC) seated volunteers for a curriculum development Visiting Committee for the new NFPA 1010 Firefighter I and Firefighter II standards. The new 1010 standard is part of the NFPA standards consolidation project.
 - Members of the Visiting Committee (VC) will be responsible for determining what students should know and be able to do, what the structure of the courses should look like, and how student skill and understanding should be measured.

- Volunteers selected for the VC will guide the Division of Fire Standards and Training & EMS in creating the curriculum and instructional materials, testing materials, and other requirements outlined in Administrative Rule. The VC will meet once per month to review work done by Division curriculum developers and instructional designers. This process will finish when the curriculum is ready to be presented to the FSTC for approval and public comment.

CURRICULUM

- ➤ Hazardous Materials: The FST Commission has approved the revised programs after the conclusion of the public comment sessions
- ➤ Fire Inspector: The visiting committee for First Responder Inspector (formerly Inspector I) and Fire Inspector (formerly Inspector II) continues to meet. An extension of accreditation has been requested for the current Fire Inspector programs.
- > Fire Investigator: The Investigator certification was approved by the Pro Board for reaccreditation.
- Firefighter I & II: The 2024 Practice Analysis results and data was presented to the FST Commission at the November meeting.
- ➤ Airport Firefighter: An administrative update of the Airport Firefighter curriculum is under way. No Job Performance Requirements (JPRs) changed when the old NFPA 1003 standard was consolidated into the new NFPA 1010 standard. This administrative update is currently available for the standard public comment period

"On My Time" Program

- To date over 3,000 students have completed individual online modules and over 200 skills modules.
- We continue to offer support and guidance to many departments participating in this program.

> Special Programs

- FirstNet First Responder Network Authority Richard Flynn campus Concord, December 11th
 - This training program is delivered by the FirstNet Authority to better understand the development, features and use of broadband networks to enhance fire service communications.
 - This program is developed with eight modules ranging from the use of broadband within the fire station, interaction between broadband networks (LTE) and land mobile radio (LMR) networks, security of broadband networks, to advanced discussions on how broadband networks operate. Building Code Review Board – (Chief Conley/Asst. Chief Pouliot) – Report submitted for minutes:

Here are some highlights from October's meeting, the chair cancelled the November meeting.

We discussed how the last couple of rounds, codes in effect July 1st but signed by Governor in August and made retroactive. Concurrency period gives 6 months to use old code. Impact is if bill doesn't float to top in June, we are left with a bill going into effect retroactively on July 1st.

There has been a lot of back and forth with the energy code, LSR 2025-0131: Relooking at 2021 Energy code, BCRB is staying out of that. Will be speaking with the legislative

committees after the election when we know who the Chairs are. If the bill moves forward, there is housekeeping that needs to be done. The Board's position on 2021 energy code remains the same.

Administrative rule review – BCR100, BCR200: BCR's – the next step with these is to look through them again, and make sure they are in the proper format. (Discussion on this began at the September meeting of the BCRB)

We did a review of the code adoption process as there are new board members who may not be familiar with the process. Reviewed "How Statewide Building Code Amendments Are Adopted."

Manufactured Housing Installation Standards Board: (Chief Blanchette) -

The board met October 18 and was introduced to the new Communications Administrator Christina McCullough who handles all public relations communications and press releases for the OPLC. The board was also introduced and had a chance to meet the new Executive Director of the OPLC Deanna Jurius.

The board voted to approve and move forward the adoption of the Inst 100, Inst 300, & Inst 600 rules for the Manufactured Housing Installation Standards Board.

The board reviewed the initial proposal on the Inst 400 rules and approved to have them sent back to legal for final review.

The board conducted a public hearing on the Inst 500 rules and no public comment was received. Those will also be sent back for final legal review.

The board received and reviewed the final proposals on the Inst 700 rules which are still waiting for some diagrams of proper concrete slab installation, proper tie down installation, & proper blocking and leveling installation. The Inst 800 final annotated proposal rules were reviewed and should be moving forward to a public hearing shortly.

There was one complaint received by the board which was reviewed in a non-public session. The minutes of the non -public meeting were sealed at the conclusion of the meeting.
